

MOBILE CRANE (TRUCK MOUNTED) OPERATION

An 92-hour course that leads to a Certificate of Successful Completion required by MOM for registration to be a Mobile Crane (Truck Mounted) Operator.

COURSE OBJECTIVES

This course provides training in the knowledge and skills of mobile crane (truck mounted) operation.

COURSE CONTENTS

This course consists of 2 modules:

Module 1 (Theory)

- * Principal components and configuration of mobile crane
- * Safety devices and indicators
- * Introduction to WSHA and subsidiary legislations
- * Duties and responsibilities of crane operator
- * Interpretation of load chart
- * Job site consideration and safe operation of crane
- * Risk Assessment and Permit-to-Work for lifting operations

Module 2 (Practical)

- * Daily and weekly Inspection
- * Job site consideration and setting of out-rigger
- * Basic crane operation and Safety in lifting operations
- * Hand signals and telecommunication
- * Practical lifting operations



CERTIFICATION

Participants who have attended at least 75% of the training sessions and passed the course assessments will be issued with the BCA Certificate of Successful Completion (CSC).

ENTRY REQUIREMENT

- * **At least 18 years of age**
 - 60 years old and above are strongly advise to undergo medical certification before enrolment. MOM requires applicants 60 years old and above to undergo medical certification by a Singapore registered Medical Practitioner before licensing.
- * **Must possess a class 4 driving licence or class 5 driving licence.**
 - Participants with class 4 driving licence can only collect their certificate after they have passed their class 5. They must do so within 1 year after passing the assessment.
- * **Singapore Citizens Or Singapore PR; or**
- * **Sponsoring Company of Construction Work Pass holders, who wish to apply for this course,**
 - must submit an endorsed copy of Form C under the "Temporary Relaxation Scheme" and be subjected to its prevailing terms and conditions.
 - existing crane & hoist operators who wish to cross train in other cranes, need not submit a copy of endorsed Form C under the Temporary Relaxation Scheme.

- * **Work Permit holders from Other industries**
 - may apply for this course subject to availability and MOM licensing conditions.

Assessment: 1 Day (Total 6 hours), 9.00am - 6.00pm

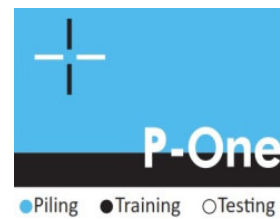
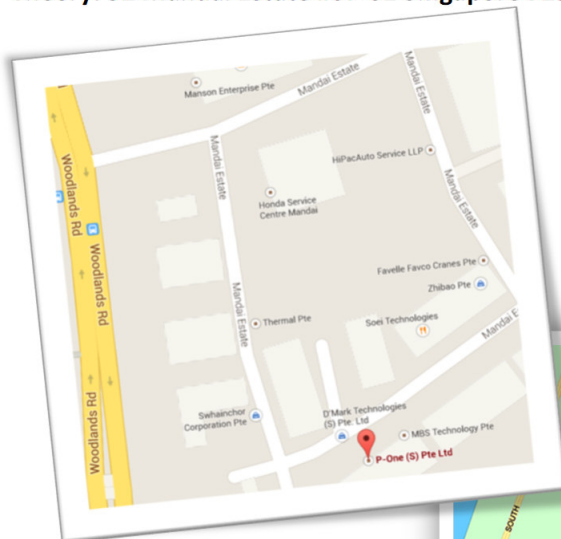
